





1.0. PREFACE

- 1.1 The SRI GANGANAGAR ZILA DUGDH UTPADAK SAHKARI SANGH LTD., HMH, invites competitive e-bids from reputed parties owning road milk tankers and engaged in the business of transportation of milk, for transportation of raw/pasteurised milk of all types including concentrated milk to and from various Dairy Plants, Chilling Centres and other chilling/processing facilities to and from various destinations like Mother Dairy, Pilkhua, Noida, DMS, GCMMF, Rohtak, Karnal, Dera Beas, Milk Unions within Rajasthan as well as to any destination in the country, in adherence to the detailed terms and conditions specific to transportation of milk stipulated in the Schedule-II of this tender **initially for a period of Two years. The contract may be extended further as per RTPP Act.**
- 1.2 The Managing Director, SRI GANGANAGAR ZILA DUGDH UTPADAK SAHKARI SANGH LTD., HMH reserves the right to reject any or all the tenders in full or part thereof, which in his opinion justifies such action without further explanation to the tenderers.

2.0 TENDERING PROCEDURE

- 2.2 The tender must be submitted in the prescribed form of GANGMUL Dairy, Hanumangarh. Tender form in two parts, first part is technical Bid & Second Part is Financial Bid. Part first & Part second to be uploaded separately.

2.5 LEGAL COMPETENCY OF SIGNING THE TENDER

Individual signing the tender or other documents connected with this tender must specify whether he signs as:

- 1) In case of (b) above, a copy of the partnership deed or general power of attorney duly attested by a notary public should be furnished or an affidavit on stamp paper of all the partners admitting execution of the partnership deed or the general power of attorney should be furnished.
- 2) In case of partnership firms, where no authority to refer disputes concerning to the business of the partnership has been conferred on any partner, the tender and all other related documents must be signed by every partner of the firm.



3.0 Force Majeure Clause :-

The terms and conditions mutually agreed shall be subject to the Force Majeure Clause. Neither the contractor nor the GANGMUL shall be considered in default in performance of its obligations hereunder, if such performance is prevented or delayed because of war, hostilities, revolutions, civil commotion, strike, epidemic, accident, fire, wind, flood, earthquake or because of any law, order, proclamation, regulation, or ordinance of any Government or any act of God or any other cause whether of similar or dissimilar nature, beyond the reasonable control of the party affected should one or both of the parties be prevented from fulfilling his/their contractual obligations by a state of Force Majeure lasting continuously for a period of six months, the two parties should consult with each other regarding the future implementation of the agreement/purchase order.

4.0 Settlement of disputes :

In the event of any dispute in the interpretation of the terms of Rate Approval Letter conveyed by GANGMUL or agreement executed by the firm with GANGMUL where the tankers are engaged or difference of opinion between the parties on any point in the Rate Approval Letter arising out of, or in connection with the agreement/accepted Rate Approval Letter or with regard to performance of any obligations hereunder by the either party, the parties hereto shall use their best efforts to settle such disputes or difference of opinion amicable by mutual negotiations.

All the disputes pertaining to the said contract shall vest to the jurisdiction of Courts at HANUMANGARH with which the contractor's tanker(s) are attached to.

5.0 Right of Acceptance :

The SRI GANGANAGAR ZILA DUGDH UTPADAK SAHKARI SANGH LTD., HMH does not pledge itself to accept the lowest or any tender and reserves to itself the right to accept the whole or any part of the tender offered.

6.0 Subletting & Subrogation :

The contractor shall not except with the prior consent in writing of the GANGMUL, sublet, transfer or assign the contract or part of the contract thereof or interest therein or benefit or advantage thereof in any manner whatsoever, to others. In case permission is granted then the same would be with a cess of Rs.11000/- (Rupees eleven thousand only) per tanker. However, in case of death of the milk transporter, transfer or assignment of the contract or part of the contract can take effect as per the stipulations made in the agreement executed. The GANGMUL may get a fresh agreement executed with the new transferee/assignee at their own level after ensuring that Unions retains clear charge on security amount and Bank Guarantee in case of breach of contract by such transferee/assignee. In such a case aforesaid cess will not be payable.

7. Corrupt practices :

- 7.1 The contractor shall not offer or agree to give any person in the employment of the GANGMUL any gift or consideration of any kind as an inducement or reward for doing or forbearing to do or for having done or forborne to do any act in relation to obtaining or execution of the contract or any other contract with the GANGMUL or for show for

bearing to show favour or disfavour to any person in relation to the contract by the GANGMUL. Any breach of the aforesaid condition by the contractor or any one employed by him or acting on his behalf (whether with or without the knowledge of contractor) of the commitment of any offence by the contractor or by any one employed by him or acting on his behalf under Chapter-IX of the Indian Penal Code 1860 or the prevention of corruption Act, 1947 or any other Act enacted for the prevention of corruption by public servants, shall entitle the GANGMUL to cancel the contract and all or any other contract with the contractor and to recover from the contractor the amount of any loss arising from such cancellation.

7.2 Any dispute or difference in respect of either in the interpretation effect or application of the above conditions or of the amount recoverable there under by the GANGMUL from the contractor shall be decided by the GANGMUL or his nominee whose decisions may be subject to the arbitration.

8.0 Insolvency & Breach of Contract :


The GANGMUL may at any time, by notice in writing, summarily terminate the contract without compensation to the contractor in any of the following events viz :

- (i) If the contractor, a firm or any partner thereof, shall be at that time adjusted involvement or shall have a receiving order or order for administration of his estate made against his or shall take any proceedings for composition under any insolvency Act for the time being in force to make any conveyance or assignment of his assets or enter into any arrangement or composition with his creditors or suspend of payment if the firm is dissolved under the partnership Act, or ;
- (ii) If the contractor being a company is wound up voluntarily by the order of a court or a receiver, liquidator or Manager or on behalf of the Debenture holder is appointed or circumstances shall have arisen which entitled the Court of Debenture holders to appoint a receiver, liquidator or Manager or;
- (iii) If the contractor commits any breach of the contract/ herein not specifically provided for, provided always that such determination shall not prejudice any right of action of remedy which shall have accrued or shall accrue thereafter and provided also the contractors be liable to pay the GANGMUL for any extra expenditure. He is thereby put to and the contractor shall under no circumstances be entitled to any gain in repurchase.

9.0 Recovery of sums due :

Whenever any claim for the payment of a sum of money arises out or under the contract against the contractor, the GANGMUL shall be entitled to claim it from the cash securities available with GANGMUL and the Bank concerned against the guarantee amount provided by the contractor. In the event of such cash securities and bank guarantee amount being insufficient, the balance entire sum recoverable shall be recovered by appropriating any sum due or which at any time thereafter may become due to the contractor under the contract or any other contract with the GANGMUL and if such a sum be insufficient to cover the full amounts recoverable, the contractor shall on demand pay to the GANGMUL the balance remaining dues.


SCHEDULE - IISPECIFIC TERMS AND CONDITIONS FOR TRANSPORTATION OF MILK THROUGH ROAD MILK TANKERS

1. Milk is a perishable commodity. The transportation is therefore required to be effected in shortest possible time. On an average, subject to **No Entry** conditions and the like, the tanker should cover 35 kms. per hour after leaving dispatching unit subject to minimum 600 kms. in 24 hours.

In case of any tanker taking more time or covering less distance the transporter will be liable for losses including those arising due to rejection of milk at the destination.

The tanker should therefore ply continuously to the destination once it leaves the dispatching unit's premises by maintaining the aforesaid speed and should not make unnecessary halt in transit.

2. The tanker(s) to be provided to GANGMUL shall be of Stainless Steel AISI 304 grade for inner barrel and outer Stainless Steel AISI 202/304 with proper insulation so that the same is in perfect thermal and mechanical condition to ensure that temperature of milk does not rise by more than 1^o C. in 24 hours even during the summer. This is one of the most important conditions and GANGMUL can carry out testing for temperature rise in their premises. Tankers not found conforming to this technical condition may not be allowed for transportation of milk. Outer cover of tanker barrel also stainless steel.
3. The tankers to be offered are required to be in excellent road worthy conditions and maintained as such during the contract. The model of tankers should not be older than year 2017. The GANGMUL may revise / change model condition of tankers during the contract period as per the rules and regulations notified by the State Government or Central Government or by Hon'ble High Court / Supreme Court or any other Government agency which may have jurisdiction on the business of transportation.
4. Transportation would be mostly full tanker load for each station but Union GANGMUL may direct the transporter to lift small consignment of milk for places off route/enroute. In such cases rate payable shall be as applicable for **Minimum quantity of 9000 Kgs.**
5. Milk consigned to destined place including out side Rajasthan are coordinated by the competent authorities. In case the situation so demands, the competent authorities can ask the tanker to be diverted to a different Dairy Plant. The successful tenderer(s) shall have to comply with the same.
6. The contracted tanker can also be used for transportation of water, it will be payable if this journey is conducted exclusively for this purpose. Gangmul also send material like Soda Ash, Butter can, EMT & motor etc with tanker. Material should be dispatch and received safely at our union/Milk Chilling Center .
7. The Tankers attached with SRI GANGANAGAR ZILA DUGDH UTPADAK SAHKARI SANGH LTD. HMH shall not without written permission operate at or for

any other Milk Union agency, failing which SRI GANGANAGAR ZILA DUGDH UTPADAK SAHKARI SANGH LTD. HMH may impose penalty and such lapse can even lead to cancellation of contract.

8. In case a tanker meets with an accident while transporting milk the transporter will ensure to lodge F.I.R. to the nearest Police Station. The transporter shall make immediate alternative arrangements for recovering the milk and transporting it back to the dispatching union/unit or to any other place as may be decided by the GANGMUL. He will also intimate the Insurance Company for carrying out survey of milk losses. The transporter will also intimate the first party about the accident and ensure timely submission of copy of FIR and of intimation given with confirmation in writing to the Insurance Company so that claim formalities can be completed in time. After getting the survey of milk loss done and submission of a copy of FIR, the transporter shall be allowed to get the accidental tanker lifted. The same tanker will be allowed to be operated only if fitness certificate is produced from the transport authority of State Govt. after carrying out due repairs.
9. If for any reasons whatsoever the claim received from the Insurance Company for the loss of milk etc. is less than the value of milk being transported the differential amount shall be recoverable from the transporter.
10. The transporter shall be held responsible for the loss of Fat and SNF and difference of weight as under:-
 - a) The losses shall be computed in respect of each tanker trip wise.
 - b) Loss in Fat and SNF shall be maximum 0.80 % of quantity, worked out separately for each tanker on per trip Fat and SNF dispatched.
 - c) Transportation loss beyond the permissible limit as aforesaid shall be recoverable as per prevailing NMG/RMG rates applicable.
 - d) The tanker(s) not showing loss greater than 0.1% may be given incentive by way of priority in tanker loading over those showing higher loss/variation.
 - e) The tanker will be sealed by representative of dispatching unit. The transporter shall be fully responsible for any loss to the dispatching unit in weight, Fat and SNF if the seal is found open at the receiving unit or on the way. In case of any loss caused to the dispatching unit due to loss of weight, Fat and SNF during transportation, transporter shall pay a penalty upto the extent of ten times of the losses suffered by the dispatching unit, if seal is found tampered/opened/broken. GANGMUL shall have the power to stop the tanker to check the seal on way for above purpose or any other purpose.
GANGMUL may adopt tamper proof locking system/E-lock system for sealing of tankers with mutual consent of transporter in view of the cost involved in adopting such system. However, mechanical tie rods with locking arrangement may be implemented if so desired by GANGMUL.
 - f) As regarding lifting of milk by GANGMUL from its chilling center depending upon the availability of weighment and testing facilities the chilling center send sealed control sample with tanker GANGMUL would final the testing of sealed control sample send by chilling center with tanker at QC Lab GANGMUL Hanumangarh. It difference found in FAT/SNF in control sample and tanker testing than final testing assure control sample and losses deducted from concern

transporter, in this clause if seal is found tampered/opened/broken then upto 10(ten) times of loss will be recoverable from transporter.

- g) The transporter shall have to lift milk from any other sub-unit of the GANGMUL during its return journey whether enroute or off route if directed by the concerned GANGMUL /dispatching unit. Non complains of instruction in this regard may lead to a penalty.
- h) No halting charges shall be payable to the transporter for the time taken in decanting, loading, unloading or waiting at any place.
- i) The transporter shall have to supply replacement for any tanker which goes off road for any reasons.
- j) The transporters shall have to lift sour/rejected milk from any place in Delhi or any other destination on its return journey and deliver at the decided destination dairy on the instructions of the competent officer nominated by the GANGMUL. Refusal by the transporter to lift the milk on return journey, disobedience of instructions of the competent officer, would render him liable to penalty @ Rs.11000/- per trip and also leading to cancellation of the agreement. The transporter will be required to satisfy GANGMUL that it has enough tanker capacity and sound financial position for undertaking the job required.
- k) "The rate approved in the letter of approval are based on per 9000 kg of milk transports for different RLW milk tanker which they have quoted in the tender/negotiation pro-rata increase/decrease shall be allowed depending upon the actual quantity of milk transported. The rate thus arrived at will be "Basic Rate" for that particular Registered Laden weight milk tanker. For instance if the rate for a milk tanker having registered Laden Weight of 25000 Kgs. in Rs 8/- per km. Per 9000 kgs. of milk transported and if the tanker transported 13500 kgs. of milk then the basic rate for that particular Registered Laden Weight tanker shall be $\{Rs.(8.00*13500)/9000=\}$ Rs. 12.00 per km."
- l) In case of any increase/decrease in the rate of diesel by Govt. of India / Govt. of Rajasthan on the rate prevailing on 01.01.2025 at Hanumangarh (including any increase/decrease notified for 01.01.2025), the aforesaid basic rate per kilometre will be increased/decreased reckoning 4 KM in one litre of diesel.**

For instance if the increase in diesel is Rs.1.00 per litre then for the example taken in point no. (k) the basic rate will increase by Rs.0.25 i.e. Rs.12.25 will be the rate payable.

- m) The tenderers must quote their rate based on diesel prices prevailing as on 01.01.2025 at Hanumangarh (inclusive of decrease/increase in diesel rate as on 01.01.2025 by Govt. of India/Govt. of Rajasthan).**
- n) Milk insurance charges (transit insurance) for milk transported by road tankers from GANGMUL to various destinations and within Rajasthan will not be borne by the transporters. GANGMUL will bear these insurance charges.
- o) Pathkar and Toll taxes if any, levied by State Govt./Centre Govt. shall be paid by GANGMUL to transporter on original receipts.

- p) **Breach of the contract** : The transporter shall be responsible for breach or non performance of the terms of this contract/agreement. The GANGMUL shall be entitled to terminate this contract forthwith without assigning any reason if the transporter goes into liquidation whether voluntary or compulsory. The contract will be liable to termination at the discretion of the Managing Director, GANGMUL at any time for breach in the terms of the contract by them. In such cases, the transporter shall be liable to make good all the damages/losses suffered by the GANGMUL . - q) **Assignment of subletting of contract** : **The transporter shall not assign or sublet of contract or any part thereof without the written permission of Managing Director, GANGMUL.**
- r) Payment in all cases payment will be made on the receipt of the goods as per the receipt note issued by the receiving party. The receipt note shall invariably be produced to the GANGMUL by the transporter as and when required. The payment will be made on bills raised by the transporter on "Freight to pay" basis and the payment will be effected by the GANGMUL after deductions if any within 20 days of receipt of bills duly verified and complete in all respect. The bills shall be submitted every fortnight.
- s) **The tenderer must quote the registration number of the vehicles, model, make, GVW, RLW, ULW etc. explicitly which he owns in his tender and must attach a copy of Registration Certificate of vehicle issued by Transport Authority failing which tanker will not be considered for allotment.**
- t) In case of partnership concern the partnership deed is required to be produced.
- u) The transporter shall be responsible for compliance of relevant rules of the Motor Vehicle Act as well as those of Pollution Control Department of State of Rajasthan / any other State / Central Government / Supreme Court / any other Court of law and government agency. The tanker has to meet environmental stipulations of not only Rajasthan State but also other States the tanker plies through has also specially those stipulations made by receiving unit like Mother Dairy, Delhi and other destination units. Loss due to lapses on these accounts will be recoverable from the transporter.

The transporters shall ensure that the total weight of filled tanker does not exceed the limit prescribed by Transport Authority in the Registration Certificate of the concerned tanker.

- v) If the amount of loss caused to GANGMUL by the transporter on account of any reason whatsoever, attributable to the transporter, is more than due payments of the transporter including security deposit, Bank Guarantee etc. then excess amount of loss will be recovered from any due payment of transporters.

w) GANGMUL shall be free to terminate contract any time if the tanker staff (Driver/Helper etc.) does not behave in proper way and /or the conduct of the transporter is not upto the mark. Any lapse on the part of the transporter including his tanker staff shall be viewed seriously and such tanker(s) will be liable to be debarred from transporting milk at any place. GANGMUL shall be free to impose penalty for such lapses and for not maintaining discipline.

x) If any tanker engaged by the milk transporter is found indulged in pilferage /theft of milk during transportation by Police/Vigilance team of GANGMUL/RCDF/Other sources or the firm is found indulged in any other corrupt practice carried out at GANGMUL/ Chilling Centre / receiving end etc. GANGMUL at its own discretion may lodge F.I.R. against such transporter. The agreement / contract of the milk transporter can be terminated and such firm can be blacklisted at the discretion of GANGMUL and due amount shall be forfeited / adjusted against the losses suffered by the Milk Union and upto 10(Ten) times penalty amount may be imposed by GANGMUL for such an act of pilferage/theft/corrupt practices. Which will be recovered from the transporter from his pending Bills etc

IF any staff of Transporter is found indulged in any type of theft of milk, milk products & other material inside dairy plant/chilling center premises , penalty to the extent of 20 times of value of such theft shall imposed. The driver and helper of such tanker shall be prohibited from further operation penalty recover from pending bill.

y) The transporter shall have to maintain proper hygiene of the tanker as a whole to the entire satisfaction of GANGMUL FSMS ISO22000:2005 & FSSAI Norms. All milk tankers shall be painted with name of the GANGMUL, Registration number of the tankers on rear side of the tanker barrel (valve side) as well on both the longer sides of the barrel in bold letters conspicuous enough so that the same can be read from a long distance. The tanker should have proper sealing and welding of the bolts on hinges. GANGMUL can effect changes in the colour scheme or the text to be painted. Such changes, if made during the currency of contract, the same shall be affected by the transporter at no extra cost. The transporter shall also ensure proper cleaning and sanitation of tanker before filling of milk.

11. In case any tanker is disengaged by the GANGMUL whether on the request of the transporter or on completion/termination of contract or for any other reason whatsoever the name, logo of GANGMUL, art & design shall be removed/erased/painted plain immediately.
12.
